New Business

Cindy Mueller said the school board is proposing a \$150,000,000 bond which includes new junior high-school, all schools to be air conditioned, a gym in Eisenhower, a softball complex and land for a future elementary school, when the need arises. The committee meeting to discuss this will be held May 1. The meeting is open to the public, but no public input will be available at this meeting.
